

## Affiliate Complimentary Memberships

### Guidelines

- Each affiliate in good standing (paid dues and completed annual report) has access to seven complimentary memberships each year.\*
- Complimentary memberships are not carried over year to year.
- The complimentary member must be a member of your affiliate. The selection criteria should be defined by the affiliate.
- The individual must be a **new** TESOL member or someone who has not been a member in more than five years. *Renewing TESOL members or current TESOL members do not qualify and the membership applications will be returned. Member status will be verified upon receipt.*
- The seven individuals must each complete a TESOL membership application. The name of the affiliate must be listed as the name of the referrer.

### How to Submit

- Additional payments for membership upgrades must be included with the applications.

*\*TESOL affiliates located in countries with a GDP of less than US\$3,000 receive 3 complimentary memberships for leaders each year. These complimentary memberships are separate from the 7 available after annual dues are paid.*
